AN ORDINANCE TO APPROVE, ADOPT AND ENACT THE CODIFICATION OF THE LAND USE ORDINANCES OF THE BOROUGH OF FRENCHTOWN, COUNTY OF HUNTERDON, STATE OF NEW JERSEY; AND PROVIDING FOR THE CONTINUATION OF PREVIOUS PROVISIONS

Be it ordained and enacted by the Mayor and Council of the Borough of Frenchtown, County of Hunterdon, State of New Jersey, as follows:

§ 1. Approval, adoption and enactment of Code.

The land use ordinances of the Borough of Frenchtown of a general and permanent nature adopted by the Mayor and Council of the Borough of Frenchtown through April 7, 2021, as codified, consolidated and numbered into Chapter 50, are hereby approved, adopted, ordained and enacted as the “Land Use Ordinances of the Borough of Frenchtown.” Subsequent land use ordinances, regardless of inclusion in the Land Use Ordinances Volume, are specifically saved from repeal.

§ 2. Nonsubstantive changes in previously adopted legislation.

In compiling and preparing the Borough's land use ordinances for codification, no changes in the meaning or intent of such legislation have been made. Certain grammatical changes and other minor nonsubstantive changes were made, and original ordinance numbering has been revised to reflect Code chapter numbering. It is the intention of the Mayor and Council of the Borough of Frenchtown that all such changes be adopted as part of the Land Use Ordinances Volume as if the ordinances had been previously formally amended to read as such.

§ 3. Continuation of provisions.

- A. The provisions of this Land Use Ordinances Volume, insofar as they are substantively the same as those of ordinances in force immediately prior to the enactment of this ordinance, are intended as a continuation of such ordinances and not as new enactments, and the effectiveness of such provisions shall date from the date of adoption of the prior ordinance. All such provisions are hereby continued in full force and effect and are hereby reaffirmed as to their adoption by the Mayor and Council of the Frenchtown, and it is the intention of said Mayor and Council that each such provision contained within the Land Use Ordinances Volume is hereby reaffirmed as it appears in said Land Use Ordinances Volume.
- B. For purposes of transition from Ord. No. 564, as amended, to this Land Use Ordinances Volume, any reference to a section number from the original ordinance(s) on or in any form, license, permit, ticket or other Frenchtown document shall be deemed to refer to the corresponding section in this Land Use Ordinances Volume until such form, license, permit,

ticket or other Frenchtown document is revised or reprinted to refer to the numbering in this Land Use Ordinances Volume.

§ 4. When effective.

This ordinance shall take effect immediately upon passage and publication according to law.
