RESOLUTION #2004-69

WHEREAS, the Borough of Frenchtown has public parking lots and may establish new public parking lots in the future, and;

WHEREAS, the Frenchtown Borough Council has adopted Ordinance #542 which controls parking in the Borough public parking lots, and;


WHEREAS, Ordinance #542 provides for issuance of overnight parking permits upon application pursuant to requirements and fee to be established by resolution of the Frenchtown Borough Council, and;

WHEREAS, Ordinance #542 further provides that the Frenchtown Borough Council may by resolution establish requirements for determining those persons entitled and authorized to receive and overnight parking permit.


NOW THEREFORE BE IT RESOLVED by the Mayor and Common Council of the Borough of Frenchtown as follows:

1. Overnight parking permits shall be issued with the following statement: "This overnight parking permit shall allow one vehicle to be parked in a Frenchtown Borough parking lot overnight. This permit does not guarantee the holder of the permit to a parking space in any Borough parking lot and does not entitle the holder to reserve a parking space."
2. Overnight parking permits shall be valid for one year, ending December 31", except for the initial permit issued in accordance with this resolution, which shall expire December 31, 2005, even if issued in 2004.
3. The Frenchtown Borough Clerk is empowered to issue overnight parking permits upon application therefore on a form to be prepared by the Borough Clerk.
4. The overnight parking permit shall only be issued to a licensed driver or to owners of hotels and bed and breakfasts within the Borough limits and additional permits may only be issued to the same person upon nonrenewal of an outstanding permit.
5. The permit fee for issuance of the annual overnight parking permit shall be \$5.00 for residents of the Borough of Frenchtown and \$25.00 for non-residents and \$25.00 for an annual hotel guest permit.
6. Upon payment of the fee and completion of the application process, the licensed driver will receive a parking permit window sticker which shall be permanently attached to the rear driver side window in the lower left hand corner.
7. The hotel and bed and breakfast guests will display in the windshield of their car an 8 1/2" x 11" placard with parking permit attached.
8. Vehicles parked in the same space for one week or more are subject to a ticket.
